## INVITATION TO BID FOR LABORATORY EQUIPMENT

- 1. The Industrial Technology Development Institute, through General Appropriations Act (GAA) Locally Funded Project "Enhancement of the Competence and Capabilities of the National Metrology Laboratory of the Philippines Project 1: Chemical Metrology for Organic Contaminants in Foods and Water" FY 2017 intends to apply the sum of Seven Million Pesos only (Php 7,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for one (1) lot Thremogravimetric Analyzer-Differential Scanning Calorimetry (TGA-DSC). Bids received in excess of the ABC shall be automatically rejected at the bid opening.
- 2. The Industrial Technology Development Institute (ITDI) now invites bids for one (1) lot Thermogravimetric Analyzer-Differential Scanning Calorimetry (TGA-DSC). Delivery of the Goods is required within Ninety (90) Calendar Days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
  - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- Interested bidders may obtain further information and inspect the Bidding Documents at the ITDI BAC Secretariat, Second Floor Metrology Bldg. starting November 21, 2017 from 8:00AM – 4:00PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders from November 21, 2017 until December 11, 2017 from the ITDI BAC Secretariat, Second Floor Metrology Bldg. upon payment of the applicable fee for Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (P 10,000.00) only.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The ITDI-BAC will hold a Pre-Bid Conference on November 27, 2017 at 9:00 A.M at the Metrology Conference Room, 2<sup>nd</sup> Floor ITDI Metrology Building, DOST Compound Gen. Santos Ave. Bicutan, Taguig City.

All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18:
- Bid opening shall be on December 11, 2017 and shall start at 1:30 P.M. at the Metrology Conference Room, 2<sup>nd</sup> Floor, ITDI, Metrology Building, Bicutan, Taguig City. Bids will be opened in the presence of the bidders' representatives who choose to attend. Late bids shall not be accepted.

The Industrial Technology Development Institute (ITDI) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
