INVITATION TO BID FOR LABORATORY EQUIPMENT

1. The Industrial Technology Development Institute, through General Appropriations Act (GAA) Locally Funded Project "Enhancement of the Competence and Capabilities of the National Metrology Laboratory of the Philippines – Project 1: Chemical Metrology for Organic Contaminants in Foods and Water" – FY 2017 intends to apply the sum of Six Million Nine Hundred Thousand Pesos (P6,900,000.00) only being the Approved Budget for the Contract (ABC) to payments under the contract for the following:

Bids received in excess of the ABC shall be automatically rejected at the bid opening.

- 2. The Industrial Technology Development Institute (ITDI) now invites bids for the above-mentioned equipment. Delivery of the Goods is required within Ninety (90) Calendar Days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- Interested bidders may obtain further information and inspect the Bidding Documents at the ITDI BAC Secretariat, Second Floor Metrology Bldg. starting November 21, 2017 from 8:00AM – 4:00PM.
