INVITATION TO BID FOR LABORATORY EQUIPMENT

1. The Industrial Technology Development Institute, through DOST GIA "Upgrading and Enhancing the Capacity of the Packaging Technology Division in Packaging Research and Innovation" intends to apply the sum of **Two Million Seven Hundred Thousand Pesos (P2,700,000.00)** only being the Approved Budget for the Contract (ABC) to payments under the contract for **one (1) lot Respiration Meter for Fresh Produce**. Bids received in excess of the ABC shall be automatically rejected at the bid opening.
2. The Industrial Technology Development Institute (ITDI) now invites bids for abovementioned equipment. Delivery of the Goods is required within **Ninety (90) Calendar Days**. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information and inspect the Bidding Documents at the **ITDI BAC Secretariat, Second Floor Metrology Bldg.** starting **June 21, 2018 from 8:00AM – 4:00PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders from **June 21, 2018 until July 11, 2018** at the ITDI BAC Office, Second Floor Metrology Bldg. upon payment of the applicable fee for Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (P5,000.00) only**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The ITDI-BAC will hold a **Pre-Bid Conference** on **June 28, 2018 at 9:00 A.M** at the **Metrology Conference Room, 2nd Floor ITDI Metrology Building, DOST Compound Gen. Santos Ave. Bicutan, Taguig City**.
7. Bids must be duly received by ITDI-BAC Secretariat at the **Metrology Conference Room, 2nd Floor., ITDI Metrology Building, DOST Compound Bicutan Taguig City** on **July 11, 2018 between 8:30 AM – 8:45 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18:


