### INVITATION TO BID

## DESIGN & BUILD

OF

#### UPGRADING OF EXISTING MAIN COLD-WATER LINE FOR ITDI BUILDINGS-CO-2019-01 REBID

- 1. The INDUSTRIAL TECHNOLOGY DEVELOPMENT INSTITUTE, through the General Appropriations Act (GAA) Project "Repair/Renovation and Maintenance of ITDI Buildings and Facilities" intends to apply the sum of Three Million Nine Hundred Thousand Pesos (Php3,900,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Labor and Materials for the rebidding of the Design and Build of Upgrading of Existing Main Cold-Water Line for ITDI Buildings-CO-2019-01. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The INDUSTRIAL TECHNOLOGY DEVELOPMENT INSTITUTE (ITDI) now invites bids for the Supply and Delivery of Labor and Materials for the Design and Build of Upgrading of Existing Main Cold-Water Line for ITDI Buildings-CO-2019-01. Location: ITDI-DOST Compound Gen. Santos Bicutan Taguig. Completion of the Works is required within One Hundred Eighty (180) calendar days.
- 3. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
- 5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 6. Interested bidders may obtain further information from *ITDI BAC Secretariat* and inspect the Bidding Documents at the address given below starting **May 2, 2019** from *9:00 a.m. to 4:00 pm*.
- 7. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Five Thousand Pesos (Php 5,000.00)*.
- 8. The ITDI-BAC will hold Pre-Bid Conference on May 9, 2019 at 9:00 A.M. at the Metrology Conference Rm., Metrology Building, DOST Bicutan, Taguig City.
- 9. Bids must be delivered to the address below on *May 22, 2019 between 8:30 to 9:00 am.* at the *Metrology Conference Room*, *2<sup>nd</sup> Floor., ITDI Metrology Building, DOST Compound Bicutan, Taguig City.* All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on *May* 22, 2019, 9:01 a.m. at the Metrology Conference Room, 2<sup>nd</sup> Floor ITDI Metrology Building, DOST Compound Bicutan, Taguig City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Bids submitted after 9:00 a.m. on April 8, 2019 shall not be accepted.

Opening of the financial proposal will on May 22, 2019, 2:00 p.m. at the Metrology Conference Room, 2<sup>nd</sup> Floor ITDI Metrology Building, DOST Compound Bicutan, Taguig City.

- 10. The INDUSTRIAL TECHNOLOGY DEVELOPMENT INSTITUTE (ITDI) reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
- 11. The Bidders shall submit **three (3) copies** of their duly accomplished eligibility requirements, Technical and Financial Proposal into **three (3) separate sealed envelopes**.
- 12. The participating bidders/contractors should have completed similar project of at least 50% of the ABC, and have the key personnel and equipment, (listed in the eligibility forms) available for the prosecution of the contract. The BAC will use non-discretionary pass and fail criteria in the eligibility Check/Screening as well as the examination of the bids. The BAC will conduct post qualification of the lowest calculated bid.
- 13. The ITDI reserves the right to reject any and all bids, declare a failure of bidding, and not to award the contract if 1.) there is a prima facie evidence of collusion between appropriate public officers or employee, or between the BAC and any of the bidders themselves, or between the bidders and a third party, including any act which restricts, suppresses, or nullifies or tends to restrict, suppress or nullify competition; 2.) the BAC is found to have failed in the prescribed bidding procedures; or 3) for any justifiable and reasonable ground where the award of the contract will not redound to the benefit of the government as defined in the IRR.
