



## INVITATION TO BID FOR LABORATORY EQUIPMENT

- The **Industrial Technology Development Institute**, through **DOST-GIA: "Upgrading and Enhancing the capacity of Packaging Technology Division in packaging research & innovation"** intends to apply the sum of **Eight Million Pesos (Php 8,000,000.00)** only being the Approved Budget for the Contract (ABC) to payments under the contract for the following:

- The **Industrial Technology Development Institute (ITDI)** now invites bids for abovementioned equipment. Delivery of the Goods is required within **Thirty (30) – Forty Five (45) Calendar Days for Office and Laboratory Furnitures and Fixtures and Ninety (90) Calendar Days for Converting Machine**. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- Interested bidders may obtain further information and inspect the Bidding Documents at the **ITDI BAC Secretariat, Second Floor Metrology Bldg.** starting **October 4, 2021 from 8:00AM – 4:00PM**.
- A complete set of Bidding Documents may be acquired by interested Bidders from **October 4, 2021 until October 25, 2021** at the ITDI BAC Office, Second Floor Metrology Bldg. upon payment of the applicable fee for Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount as follows:

1 lot Converting Machine	10,000.00

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPs), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
