INVITATION TO BID FOR LABORATORY EQUIPMENT

- 1. The Industrial Technology Development Institute, through "VIP Project 2 Combination Therapy: Lytic Bacteriophages and Plant Extracts against Multidrug-Resistant Bacteria" intends to apply the amount of Five Million Pesos (Php 5,000,000.00) only being the Approved Budget for the Contract (ABC) to payment for the "Supply, Delivery, Labor, Installation and Commissioning of One (1) lot High Performance Liquid Chromatography".
- 2. The Industrial Technology Development Institute (ITDI) now invites bids for the abovementioned equipment. Delivery of the Goods is required within One Hundred Twenty (120) Calendar Days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information and inspect the Bidding Documents at the ITDI BAC Secretariat, Second Floor Metrology Bldg. starting February 11, 2022 from 8:00AM - 4:00PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders from February 11, 2022 until March 1, 2022 at the ITDI BAC Office, Second Floor Metrology Bldg. upon payment of the applicable fee for Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount as follows:
