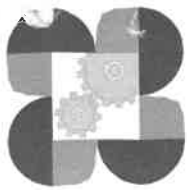

This statement shall be supported with any of the following
 - Notice of Award and/or Contract; or Notice to Proceed issued by the owner or the agency, or
 - Copy of the end user's acceptance or official receipt(s) for issued contract

- d. Audited Financial Statements, showing, among others, the prospective bidder's total and current assets and liabilities stamped "received" by the BIR or its duly accredited and authorized institution for calendar year 2019 and 2020;
- e. Computation of Net Financial Contracting Capacity (NFCC);
- f. Bid Securing Declaration, or any form of Bid Security, in an amount not less than the required percentage of the Approved Budget of Contract and in prescribed form and validity period;
- g. Technical Specifications should include the ff:
 - Production/delivery schedule
 - Manpower requirements
 - Warranty certificate
 - Brochures
 - Certificate of training of service engineers
 - Authorization from manufacturer
 - Country of origin
 - Certificate of availability of parts within five (5) years
 - Certificate of Exclusive Distributorship, if applicable
 - After sales service/parts;
- h. Omnibus Sworn Statement by the prospective bidder or its duly authorized representative in the form prescribed by the GPPB.

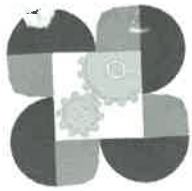

 - c. Detailed Breakdown of the Contract Cost (Main Equipment, Accessories, Training, Installation Cost, etc.)
 - d. Recurring and maintenance cost, if applicable
3. Bid opening shall be on **March 14, 2022** and will start at **9:01 A.M.** at the **Metrology Conference Room, 2nd Floor, ITDI, Metrology Building, Bicutan, Taguig City**. Bids will be opened in the presence of the bidders' representatives who choose to attend. Late bids shall not be accepted.
