

## INVITATION TO BID FOR LABORATORY EQUIPMENT

1. The Industrial Technology Development Institute, through “Establishment of biodegradability, Eco-toxicity, and compostability testing facility in the Philippines (BEC-LAB)” intends to apply the amount of **Six Million Pesos (Php 6,000,000.00)** only being the Approved Budget for the Contract (ABC) to payment for the “**Supply, Delivery, Installation and Commissioning of One (1) lot Total Organic Carbon Analyzer**”.
2. The **Industrial Technology Development Institute (ITDI)** now invites bids for the above-mentioned equipment. Delivery of the Goods is required within **One Hundred Twenty (120) Calendar Days**. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
  - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information and inspect the Bidding Documents at the **ITDI BAC Secretariat, Second Floor Metrology Bldg.** starting **June 11, 2025 from 8:00AM – 4:00PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders from **June 11, 2025 until July 3, 2025** at the ITDI BAC Office, Second Floor Metrology Bldg. upon payment of the applicable fee for Bidding Documents amounting to **Ten Thousand Pesos (P 10,000.00)**, pursuant to the latest Guidelines issued by the GPPB.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The ITDI-BAC will hold a **Pre-Bid Conference on June 19, 2025, 9:00 A.M.** at the **MIC Conference Room, 4<sup>th</sup> Floor, ITDI Metrology Building, DOST Compound Bicutan Taguig City**.



8. Bid opening shall be on **July 3, 2025** and will start at **9:01 A.M.** at the **Metrology Conference Room, 2nd Floor, ITDI Metrology Building, DOST Compound Bicutan Taguig City**. Bids will be opened in the presence of the bidders' representatives who choose to attend. Late bids shall not be accepted.
