This Agreement made and entered into by and between:

WHEREAS, the ITDI is desirous that the Contractor execute the Repair, Renovation and Maintenance of ITDI Buildings and Facilities, hereinafter called "the Works" and the ITDI has accepted the Bid for ONE MILLION FIVE HUNDRED TWELVE THOUSAND FIVE HUNDRED NINETY FIVE PESOS AND 18/100 Only (Php1,512,595.18) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

- The ITDI hereby covenants to pay the Contractor in consideration of the execution and completion of the Works, the Contract Price of ONE MILLION FIVE HUNDRED TWELVE THOUSAND FIVE HUNDRED NINETY FIVE PESOS AND 18/100 Only (Php1,512,595.18) or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- 4. In consideration of the payments to be made by the ITDI to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the ITDI to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- The whole works comprised in this Agreement shall be completed within Fifty (50) calendar days counted from receipt of Notice to Proceed. The Repair, Renovation and Maintenance of ITDI Buildings and Facilities of shall be completed and ready for use not later than February 28, 2014.
- 6. The "As built" drawings shall be submitted to ITDI not later than five (5) calendar days from completion of the entire Works, not later than March, 2014. The amount to be withheld for failing to produce the "as built" drawings

and/or operating and maintenance manuals on the date required shall be equivalent to 10% of the cost of the Works.

- In case the contractor refuses or fails to satisfactorily complete the Works 7. stipulated herein within the specified contract time, plus any time extension duly granted, and is hereby in default under the contract, the contractor shall pay the ITDI liquidated damages for each calendar day of delay, in an amount to be determined and paid in accordance with the Implementing Rules and Regulations of R.A. 9184 and further stipulated in the General Conditions of the Contract Clause 9.
- The implementation of this Agreement is further governed by the Contract 8. Implementation Guidelines for Procurement of Infrastructure Projects issued by the Government Procurement Policy Board (GPPB) as Annex E of the IRR of R.A. No. 9184 as well as such other laws and issuances applicable to this Agreement.
