CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENT

THIS AGREEMENT, made this ____ day _____ 2016 between the **Industrial Technology Development Institute (ITDI)** of the **Department of Science and Technology (DOST)**, DOST Compound, Gen. Santos Ave., Bicutan, Taguig City, hereinafter called the "ITDI",

and

CLEANWAY Environmental Management Solutions Inc., Herma Building, 94 Scout Rallos Street, Bgy. Sacred Heart 1103, Quezon City, Philippines hereinafter called the "**Consultant**".

WHEREAS, the ITDI is desirous that the Consultant execute **Consulting Services for the Repair/ Renovation and Maintenance of ITDI Building and Facilities, Package A: Maintenance of Standards and Testing Division Building Basement – Waste Water Treatment and Disposal; Transportation of Wastes, Disposal of Contaminated Solid Wastes; Permitting; Basement and Reservoir Cleaning, Clearing and Waterproofing; Issuance of Completion Certificate; Issuance of Certificate of Treatment & Disposal stamped by DENR.**, hereinafter called the "the Works" and the Entity has accepted the bid for **Two Million Four Hundred Twenty-Eight Thousand One Hundred Twenty Eight Pesos & Eighty Eight Centavos (PhP 2,428,128.88)** by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Terms of Reference
 - (c) Request for Expression of Interest;
 - (d) Instructions to Bidders;
 - (e) Bid Data Sheet;

- (f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (h) Eligibility requirements, documents and/or statements;
 - (i) Performance Security;
 - (j) Credit line issued by a licensed bank, if any;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the **ITDI** to the **Consultant** as hereinafter mentioned, the **Consultant** hereby covenants with the **ITDI** to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The **ITDI** hereby covenants to pay the **Consultant** in consideration of the execution and completion of the Consulting Services, the Contract Price of **Two Million Four Hundred Twenty-Eight Thousand One Hundred Twenty Eight Pesos & Eighty Eight Centavos (PhP 2,428,128.88)** or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


